



## CONDITIONS OF ENTRY 2020

Please read all conditions carefully.

- 1) OUR SCHOOL ACCEPTS THE QTF & SCHOOL SPORT CODES OF CONDUCT AND WE ACKNOWLEDGE THE PENALTIES WHICH MAY APPLY.
- 2) ALL REGISTERED PLAYERS ARE TO BE BONA FIDE STUDENTS OF THE SCHOOL NOMINATED. (Absolutely no teams to contain players from differing schools without written consent from Tournament Director)
- 3) WE ACKNOWLEDGE ENTRY IS VOID UNTIL PAYMENT IS RECEIVED. (DEADLINE FOR PAYMENT IS STRICTLY, (Friday 3 April 2020. (note - late payments made after 3 April shall incur a \$A50 per team late fee)
- 4) WE ACKNOWLEDGE THAT OUR TEAM/S SHALL BE REQUIRED TO PLAY AT ANY TIME DURING THE EVENT TO GUARANTEE ENTRY (the minimum commitment is 2 school days - see point 10 below).
- 5) WE ALSO ACKNOWLEDGE THAT AS PER CONDITION 4. ABOVE, OUR SCHOOL MAY BE REQUIRED TO PLAY A PRELIMINARY GAME (Before the QAS begins) SHOULD THE SCHOOL BE UNABLE TO FULFILL ALL DRAW REQUIREMENTS.
- 6) WE ACCEPT THAT A 100 % FEE WILL APPLY TO TEAMS WHO WITHDRAW AFTER THE INITIAL DRAW (also see #11 below) HAS BEEN CONSTRUCTED. (Teams who withdraw before the draw deadline shall receive a full refund of entry fees)
- 7) WE UNDERSTAND THAT IT IS A CONDITION OF ENTRY TO SUPPLY REFEREE/S AS PER SCHEDULE BELOW, OTHERWISE A SURCHARGE SHALL BE PAYABLE. (Schools nominating either 1 or 2 teams need to supply 1 accredited non-playing referee. Schools with more than 2 teams shall be required to supply a minimum of 2 referees.)
- 8) WE ACKNOWLEDGE THAT WE MAY NOT FORFEIT ANY GAMES DURING THE EVENT WITHOUT TOURNAMENT APPROVAL AND THAT WE SHALL BE SUBJECT TO A FINE OF \$A100 PER FORFEITED GAME.
- 9) WE UNDERSTAND THAT ALL TOURNAMENT DOCUMENTATION MUST BE ENDORSED BY THE PRINCIPAL AND THAT THE SCHOOL CONTACT PERSON SHALL FULFILL ALL ORGANIZATIONAL OBLIGATIONS. (Failure to comply could result in a student being ineligible to claim insurance for injury sustained at the event.)
- 10) WE ACKNOWLEDGE THAT THERE IS ABSOLUTELY NO GUARANTEE OF ENTRY TO THE COMPETITION AND THAT PRIORITY WILL BE GIVEN TO SCHOOLS WHO CAN BEST SATISFY THE EVENT REQUIREMENTS AND OTHER CONDITIONS AS DEEMED APPROPRIATE BY QAS. (i.e. play at any time during the event)
- 11) WE ACKNOWLEDGE THE PENALTIES THAT EXIST FOR NOMINATING TEAMS AND THEN SUBSEQUENTLY WITHDRAWING THEM AT LATE NOTICE. (teams who withdraw within 10 days of the event may face suspension from the QAS in the following year. See 6. Above also.)
- 12) WE ACKNOWLEDGE THAT SHOULD INCLEMENT WEATHER INTERVENE DURING THE QAS, CAUSING ABANDONMENT OF THE EVENT, THERE SHALL BE NO REFUND OF THE EVENT LEVY. SHOULD ABANDONMENT OCCUR BEFORE THE EVENT BEGINS, A CREDIT NOTE OR PARTIAL REFUND MAY BE PAYABLE UP TO A MAXIMUM OF 50% OF THE EVENT LEVY.
- 13) OUR SCHOOL AGREES TO ACCEPT ALL REASONABLE DECISIONS IN RELATION TO TOURNAMENT ORGANIZATION AS DETERMINED BY QLD ALL SCHOOLS TOUCH, QLD TOUCH FOOTBALL & OR THE TOURNAMENT DIRECTOR.

Please note the Entry Fee below.

**Standard Entry is \$440.00** per team (inclusive of GST) provided a referee is supplied. Schools with 1 or 2 teams shall be required to supply 1 referee only. Schools with 3 or more teams shall be required to supply a minimum of 2 referees. If no referee can be supplied a one-off surcharge of \$400 if you were required to supply 1 referee and \$800 if 2 referees were required. (The levy also includes basic accident insurance cover for all Australian students only.)
