ENTRY 2025

Please read all conditions carefully.

Our school understands and accepts -

1. THAT THE APPROPRIATE ENTRY FORM NEEDS TO BE SUBMITTED BY THE CLOSING DATE – **Friday 14 February 2025**.
2. THAT OUR NOMINATION WILL NOT BE ACCEPTED IF WE CANNOT FULFIL THE MINIMUM REFEREE REQUIREMENT - BEING **THE SUPPLY OF AT LEAST ONE STUDENT REFEREE TO THE EVENT**.
3. THAT AS A PART OF #2 ABOVE, IT IS A CONDITION OF ENTRY TO SUPPLY NON-PLAYING REFEREE/S AT THE RATE OF **ONE REFEREE PER TEAM NOMINATED** up to a maximum of 4 referees, OTHERWISE A SURCHARGE (A\$250 per referee required) SHALL APPLY. (Note - All referees must be attired in the official QAS referee uniform and officiate a minimum of 10 games at the event and an audit is conducted to check compliance – please refer to Referee Policy & Guidelines 2025)
4. THAT AS PART OF #3 ABOVE, **ALL REFEREES MUST REGISTER PRIOR TO THE EVENT** and provide all the relevant information.
5. THE Relevant sport **CODES OF CONDUCT** (TFA, QTF, Qld School Sport) and is aware of the penalties which may apply.
6. THAT WE NEED TO PROVIDE A TEACHER AS THE DESIGNATED SCHOOL CONTACT AND THAT THIS PERSON IS RESPONSIBLE FOR ALL ORGANIZATIONAL MATTERS INCLUDING DISSEMINATION OF INFORMATION TO OUR SCHOOL. (see also #16 below)
7. THE CANCELLATION, WITHDRAWALS, & REFUND POLICY WHICH IS A STRICT CONDITION OF ENTRY TO THE EVENT. (see #13, #14, & #19 below)
8. THAT WE ARE REQUIRED TO REGISTER ALL STAFF & STUDENTS TO THE MYSIDELINE PLATFORM BY THE DUE DATE AND THAT ALL REGISTERED PLAYERS ARE TO BE BONA FIDE STUDENTS OF THE SCHOOL NOMINATED. (Absolutely no teams to contain players from differing schools without written consent from Tournament Director)
9. THAT ENTRY IS VOID UNTIL PAYMENT IS RECEIVED. (DEADLINE FOR PAYMENT IS STRICTLY **Friday 4 April 2025** and late charges shall apply. (see entry fee schedule below)
10. THAT OUR TEAM/S SHALL BE REQUIRED TO PLAY AT ANY TIME DURING THE EVENT TO GUARANTEE ENTRY (the minimum commitment is 2 school days - see #17 below).
11. THAT OUR TEAM/S (all players) SHALL BE REQUIRED TO PLAY IN AN APPROPRIATE TEAM UNIFORM WITH CLEARLY DISPLAYED NUMBERS. (Schools may be advised that uniforms may not be at the required standard and that alternative arrangements shall be required.
12. THAT OUR TEAM/S MAY BE REQUIRED TO PLAY A PRELIMINARY GAME (Before the QAS begins) OR A FORFEIT MAY BE APPLIED.
13. THAT an administration fee of \$83.50 will apply to any requests for changes made to teams or the entry after the Participation Advice has been submitted.
14. THAT AS PER CONDITION #7. ABOVE A 100 % FEE WILL APPLY TO TEAMS WHO WITHDRAW AFTER THE INITIAL DRAW PROCESS HAS BEGUN. (Deadline is **Friday 20 June 2025**)
15. THAT WE MAY NOT FORFEIT ANY GAMES DURING THE EVENT WITHOUT TOURNAMENT APPROVAL AND THAT WE SHALL BE SUBJECT TO A FINE OF **\$200** PER FORFEITED GAME.
16. THAT ALL TOURNAMENT DOCUMENTATION MUST BE ENDORSED BY THE PRINCIPAL AND THAT THE SCHOOL CONTACT PERSON SHALL FULFILL ALL ORGANIZATIONAL OBLIGATIONS. (Failure to comply could result in a student being ineligible to claim insurance for injury sustained at the event.)
17. THAT SCHOOLS SHOULD HAVE AT LEAST ONE REGISTERED TEACHER (MUST BE ON STAFF AT THE NOMINATED SCHOOL) TO ACCOMPANY/SUPERVISE THE TEAM/S. (An accredited Coach or Parent may be permitted to Coach the team/s, however the nominated teacher is responsible for all teams at the event.)
18. THAT THERE IS ABSOLUTELY NO GUARANTEE OF ENTRY TO THE COMPETITION AND THAT PRIORITY WILL BE GIVEN TO SCHOOLS WHO CAN BEST SATISFY THE EVENT REQUIREMENTS AND OTHER CONDITIONS (as per Criteria entry points system) AS DEEMED APPROPRIATE BY QAS. (i.e. play at any time during the event)
19. THAT PENALTIES EXIST FOR NOMINATING TEAMS AND THEN SUBSEQUENTLY WITHDRAWING THEM AT LATE NOTICE. (teams who withdraw within 10 days of the event may face suspension from the QAS in the following year.)
20. THAT SHOULD INCLEMENT WEATHER OR OTHER UNFORESEEN CIRCUMSTANCES INTERVENE DURING THE QAS, CAUSING ABANDONMENT OF THE EVENT, THERE SHALL BE NO REFUND OF THE EVENT LEVY. SHOULD ABANDONMENT OCCUR BEFORE THE EVENT BEGINS, A CREDIT NOTE OR PARTIAL REFUND MAY BE PAYABLE UP TO A MAXIMUM OF 50% OF THE EVENT LEVY. (see #7 above)
21. THAT THE OFFICIAL LOGOS ARE NOT FOR USE WITHOUT WRITTEN PERMISSION.
22. ALL REASONABLE DECISIONS IN RELATION TO TOURNAMENT ORGANIZATION AS DETERMINED BY QLD ALL SCHOOLS TOUCH, QLD TOUCH FOOTBALL & THE TOURNAMENT DIRECTOR.



Please note the 2025 Entry Fee schedule below.

Standard Entry is **\$835.00** per team (inclusive of GST) provided a minimum of one student referee is supplied for the Nomination to be accepted. Schools must also satisfy the referee quota or providing one referee per team nominated up to a maximum requirement of 4 referees. If one or more referees (other than the mandatory one) cannot be supplied, a surcharge of **\$250** per referee required will apply. Note – also that referees must officiate in both Junior and Senior divisions if the school nominates teams in both divisions)

(Note - The Event levy also includes basic accident insurance cover for all students and the official Inferno match ball.)

LATE PAYMENT FEE – A late fee of \$83.50 shall apply to all payments made after 4 April 2025.

Interstate or International Teams note - There is no referee requirement and Insurance cover is not included for non-Australian schools.
